

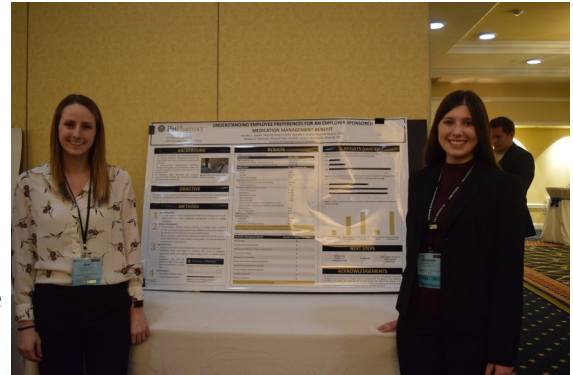

Abstract Guidelines

Abstracts are limited to 300 words and must include all of the sections (in the sequence below) in the abstract type/category that best corresponds to the authors work:

1. **Contributed Research Report AND Reports on Projects in Progress**

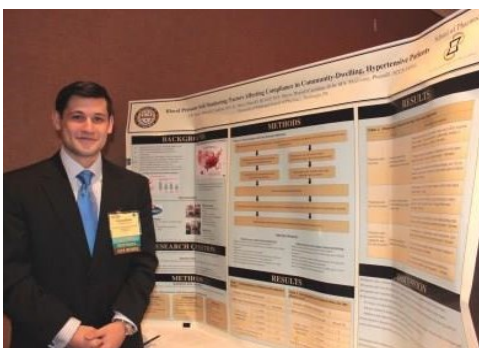
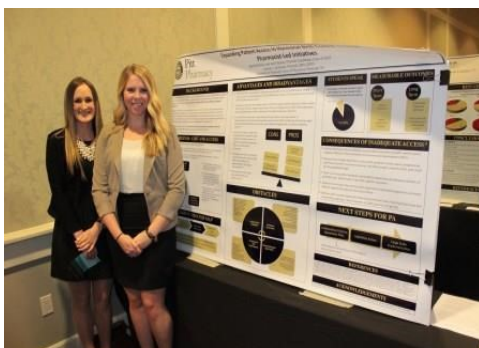
-Objective(s), Methods (e.g., design, setting, patients/participants, data collection, analysis plan, or other appropriate methods), Results (or Preliminary Results for Reports on Projects in Progress), Implications/Conclusions (as applicable)

2. **Innovative Practice Reports**

-Objective(s), Setting, Practice description, Practice innovation, Interventions, Evaluation (impact of innovation)/Results, Conclusion

The abstract title should be typed in mixed capital and lower case letters (as appropriate).

- The study's objective should be the first sentence of the abstract.
- The abstract should be clearly worded and concise.
- Graphs, tables, and illustrations are not permitted in the body of the abstract.
- Trademark symbols, subscripts, superscripts, and discretionary hyphens should be avoided.
- Standard abbreviations should be used for units of measure; acronyms must be spelled out in full at first mention and abbreviated thereafter.
- The abstract must be free of grammatical and typographical errors.



Additional Information

1. Only student members of the Pennsylvania Pharmacists Association (PPA) are eligible to present posters at this meeting. Student members may be from any accredited school of pharmacy in the U.S. as long as they are PPA members.
2. At least one of the posters' authors must be registered for PPA's Mid-Year conference and be physically present during the Presentation time frame, **Saturday, January 25, 2020, time TBA**, for pharmacist continuing education. Posters should be 3' high x 5' long or 36" x 60"
3. For students, posters must be reviewed and approved by a faculty member or preceptor. Please note a review approval is included on the application form. Posters will be subject to a final on-site review for applicability. Please note that to be accepted for a poster presentation at Mid-Year, an abstract is required in advance. See application for more information. All posters should promote problem-solving and critical thinking and be applicable to the practice of pharmacy in areas such as delivering patient-centered care, working as part of interdisciplinary teams, practicing evidence-based medicine, focusing on quality improvement and using information technology.
4. Submit application by **December 2, 2019** to PPA. Accepted applicants will receive a letter of confirmation with specific details.
5. Students will be required to file the standard PPA Disclosure statement for CE activity, either in advance or on site.
