Department of Pharmacy Overview

The Department of Pharmacy at AGH provides 24-hour comprehensive inpatient pharmacy services, utilizing a decentralized, computerized unit-dose drug distribution system, and intravenous admixture programs. EPIC serves as the electronic health record for inpatient and outpatient care. Services provided include: drug information, computerized inventory control and procurement systems, integrated drug use review, and quality improvement. Extended-hour outpatient pharmacy services are available through the AGH Apothecary for patients and employees throughout the Allegheny Health Network. Extensive in-service education and staff development programs are also available.


Pharmacists assume direct patient care responsibilities for ensuring the safe and effective use of medications, in addition to supervising supportive pharmacy personnel. Pharmacists with specialized training provide expertise in advanced principles of pharmaceutical care in areas including critical care, emergency medicine, transplantation, infectious disease, cardiology, internal medicine, hematology/oncology, ambulatory care, and drug information.

The health care setting at AGH offers an ideal environment for the training and education of pharmacists and supportive pharmacy personnel. The AGH Department of Pharmacy maintains affiliation agreements with the University of Pittsburgh, Ohio Northern University, Lake Erie College of Osteopathic Medicine, and Duquesne University Schools of Pharmacy. In addition, several preceptors serve as adjunct faculty and provide didactic lectures at Duquesne University and/or the University of Pittsburgh. Affiliations with these sites as well as professional organizations are fostered in an effort to provide formal educational programs through clerkships, externships, internships, and residencies.

The Department of Pharmacy Services at AGH is responsible for the application of specialized knowledge of drugs and drug therapy to promote the health and welfare of the community that the institution serves. The department is committed to continuously improving the quality of patient care through its support services, education, and research efforts.

Pharmacy Intern Program Overview

Schedule Requirements

- Required to work every other weekend (rotating between Daylight and Evening).
- Required to work 1-2 four and half hours shifts (5pm-9:30pm) every two weeks (Minimum 1 shift every two weeks).
- During vacations (eg summers and holidays), interns will be expected to pick up additional shifts.
- Although not likely, because we are 24 hour operation, the possibility exists for night shift coverage.
- Medication History Shifts (For those trained ONLY)
 - o On weekend day shift from 8 AM until 4:30 PM, they should do Med History in the Emergency Department/acute care nursing units.
 - The clinical on call pharmacy resident/clinical specialist will be responsible for checking all of the completed Med Rec during the shift. If we need to get in touch with the Med Rec tech/intern throughout the day we should page #2435. This pager should only be used and paged by employees in the pharmacy.
 - PLEASE NOTE: If any technician calls off on the day shift, the Med Rec technician/intern will be pulled to staff the entire day in the main pharmacy.
- Call-offs: Call pharmacy as soon as possible. You are required to make-up these shifts.

Holidays

- Interns will be scheduled two of the six holidays recognized by the hospital: New Years, Memorial Day, July 4th, Labor Day, Thanksgiving, and Christmas.
 - o Schedule will include one summer and one winter holiday.
 - o Intern holidays will be scheduled by selection basis where those with the most hours worked in the past year select their holiday first. (Effective Jan 2020 schedule)
 - Pay for holidays is premium, meaning time and a half.
- Interns are free to pick up additional holiday time as available.
- Days off (Vacations)
 - o Departmental policy must be followed for requesting time off.
 - o Per that policy, interns are allowed to request one weekend (two days) off per year.
 - If additional time is needed, intern is required to switch with another employee. These switches must not create overtime.
 - o Midterms and final exams interns will be scheduled during those dates.
 - o Interns are **responsible for their scheduled work time**. An intern must work when they are scheduled or switch with another employee when needed.

Rotation

- The pharmacy will provide coverage for one out of state (5 week) rotation in the intern's final year.
 - This request must be sent to the management team no later than 1 week after the rotation schedule is posted

- For any additional rotations out of state, the intern will be responsible for arranging their own coverage.
- Interns are expected to check e-mail periodically and complete any required training courses during this time.

Training

- Training is approximately 4 weeks in length.
- Optimal training occurs during consecutive days (eg Monday-Friday).

Responsibility	Job Description
Automated Dispensing Systems	Demonstrates proficiency with tools, techniques, processes and maintenance requirements for pharmacy automated dispensing system.
Medication Cart Fills	Fills medication carts accurately.
Repackaging Bulk Medications	Utilizes tools, techniques and process in the repackaging of bulk medications.
Pharmacy Supply Maintenance	Maintains inventory for the pharmacy department.
Sterile Compounding	Prepares intravenous products including chemotherapy.
Organization, Research, Proposals, and Implementation	Under the direction of an assigned preceptor, conducts pharmacy practice and clinical research, analyzes data, and synthesizes information into action plans.
